Elaboration

Forums were held to garner feedback from AWARE members about our CEDAW Shadow Report. After changes were made to the Shadow report, consultation was held with partners. Then it was planning for the advocacy work in New York at the United Nations. After participating in the 49th Session of CEDAW at the United Nations in New York, public forums were held to increase awareness and to discuss priority areas following the Concluding Observations.

Two CEDAW events were held: a CEDAW 101 workshop and a Public CEDAW Forum. CEDAW 101 was a three-hour workshop led by Braema Mathi that fully explained CEDAW and how it can be used as a tool for advocacy. The Public CEDAW Forum shared AWARE’s experiences at the UN, and brainstormed on how to move forward with CEDAW. Sayoni, HOME and TWC2 were also invited to this event. At the Forum, participants formed groups to discuss four issues – public education, outreach, top 3 CEDAW issues, and coalition.

A meeting place was created in AWARE to discuss Muslim matters as a way to look at reservations on CEDAW articles. This has evolved into a partnership between LeftWrite Centre and AWARE. As many issues relating to marriage and divorce lay in the Women’s Charter, two lawyers were asked to review the Charter for possible amendments to align with CEDAW. Trafficking was copiously mentioned in the Concluding Observations and a Trafficking Sub-Committee has been formed.

Research on women in poverty led to various ongoing projects, e.g. a survey on women and the economy (partnering Ngee Ann Polytechnic and the commercial sector), and older women

who are still working. The analysis of stereotypical portrayals of women has led to an ongoing review of advertising guidelines as well as discussions about media images.

As a follow-up to the Public CEDAW Forum, we made an open call to all AWARE members to be part of the CEDAW Sub-committee. Current participants of the Sub-Comm were also invited. At this meeting, participants were divided into three groups – ATI (focusing on training modules on CEDAW), lobbying efforts and the Internet. Thus far, we have only had follow-up meetings with the ATI group.

CEDAW: Make it Real focuses on the challenge of bringing CEDAW to the ground. Ideas such as the “Not OK” campaign on sexual assault did not take off. New volunteers are needed for a new proposed project “Visual Representations for CEDAW” – a collection of photos and videos of different women to represent different CEDAW articles.

Main thrust of CEDAW

At the Public CEDAW Forum, participants identified these three issues as embodying CEDAW’s main thrust:

- **Definition of equality and non-discrimination:** To be shared via CEDAW training
- **Temporary special measures:** To increase women’s political participation and to address discriminatory policies against foreign women
- **Violence against women (related to CEDAW GR 19):** Long-standing systemic issues, e.g. violence against foreign domestic workers, the need to criminalise domestic violence and marital rape, collection of statistics on domestic abuse, mandatory training for law enforcers, awareness-raising, improved access for women seeking help, protection or support.

Work on CEDAW in 2011

- **CEDAW Booklet**
With RazorShark Design providing pro bono assistance, the project was scheduled for completion by the end of 2011. The High Commission of Canada kindly agreed to sponsor the printing cost.
- **CEDAW Micro-site**
With LibComm Labs engaged for web design, a specialised AWARE CEDAW micro-site is being developed with its own symbol and an introductory video on CEDAW. Matchbox Productions is assisting with the production of two videos on two CEDAW issues.
- **Advocacy**
In October 2011, an invitation was sent out to all Members of Parliament (MP) to a closed-door consultation to discuss CEDAW and the Concluding Observations of the UN CEDAW Committee. Only MP Foo Mee Har attended. She is open to receiving questions and comments from AWARE. We also sent her Article 11 of CEDAW on Employment, as this is her area of interest. A separate consultation was also held with the Worker’s Party. This was led by Lee Sze Yong, an associate member of AWARE and member of MARUAH, who had previously met with members from the Worker’s Party about the Universal Periodic Review (UPR) and CEDAW.

Main activities in 2011	<p>Foreign wives, especially those married to men with lower incomes, face many difficulties concerning residency status, access to legal advice and representation, affordable health care, housing, etc. They have limited access to security and support systems in Singapore. Their lack of Permanent Residence puts them at risk of deportation should the marriage fail.</p> <p>This Sub-Committee has been working on a paper to identify the areas where changes are needed and to make recommendations in the formulation of laws, rules and regulations. The main focus of the recommendations is the need for foreign wives to have a clear path for gaining Permanent Residence and citizenship, access to legal advice and legal representation, as well as measures to ensure that they are properly integrated into Singapore society.</p> <p>The Sub-Committee is also making recommendations on the urgent need for governance of match-making agencies, which are currently under-regulated. This Sub-Committee's work addresses CEDAW Articles 1-5, 9 and 11 and came about as a result of the UN CEDAW Committee's Concluding Observations in 2007.</p> <p>Main activities:</p> <ul style="list-style-type: none"> • Organised a discussion with other NGOs on the issue of foreign wives. Seventeen people attended, with eight from organisations such as Star Shelter, ACMI, New Hope, Beyond Social Services and three interns from Mark Goh's law firm. The other six were AWARE members. • Started the research work, including compilation of data, writing and editing of the report. The Research & Advocacy intern Otilda Colon also contributed to the paper.
Future plans	<ul style="list-style-type: none"> • Submission of paper to policy-makers • Identifying opportune moments for advocacy • Advocate for a review of the laws and policies that impact foreign wives, in the following ways : <ul style="list-style-type: none"> - To seek the assistance of Members of Parliament to have this issue tabled and debated in Parliament - To organise a press conference to present AWARE's findings and call for amendments to the relevant laws and social structures - To run a campaign to raise awareness

Main activities in 2011	<p>This Sub-Committee conducts research on “Singles in Singapore – Choice for Space”. Singles constitute a growing proportion of Singapore’s population who are nevertheless ignored and discriminated against because they do not follow the imposed norm of marriage-based families. We aim to uncover what it is like to be single in Singapore and the impact of bias in policies and social attitudes on the lives and choices of singles at various stages. This Sub-Committee’s work addresses CEDAW Articles 1-3, 5 and 13.</p> <p>Main activities:</p> <ul style="list-style-type: none"> • Hiring and training two Research Assistants: The training was conducted by Ramdas Kamalini and Braema Mathi, with the latter conducting another session on interviewing skills. • Qualitative interviews, together with interview transcripts and narratives, were conducted and completed in April 2012.
Future plans	<ul style="list-style-type: none"> • The Sub-Committee is currently conducting a literature review, drafting findings and clarifying focal areas for advocacy to be effected by the end of 2012. • An advocacy plan will be developed, based on the completed paper, which will include raising public awareness and lobbying relevant Ministries.

Main activities in 2011	<p>Article 6 of CEDAW is dedicated to trafficking. More research must be done to move this agenda in Singapore. Work started in October 2011 to focus on the UN CEDAW Committee' Concluding Observations, which state that the State needs to ratify the Protocol to Prevent, Suppress and Punish Trafficking in Persons, especially Women and Children (Palermo Protocol). Although the government has recently announced a National Plan of Action to combat Trafficking in Persons and is moving towards ratifying the Palermo Protocol, there is an information gap and the lack of a comprehensive legal framework to combat trafficking and to provide protection for the victims.</p> <p>Main activities:</p> <ul style="list-style-type: none"> • This Sub-Committee was formed in October 2011 and is working on analysing Singapore laws relevant to trafficking and the protection of vulnerable groups such as women, children, and migrant workers. • The Sub-Committee is also working with the SMU Pro Bono Law Club on reviewing relevant laws and statutes.

Main activities in 2011	<p>There is minimal and limited recourse for victims of workplace sexual harassment (WSH) in Singapore. This contravenes CEDAW Article 11. The UN CEDAW Committee has urged the State to address this issue. Previous research done by AWARE (2008) on this issue has been used in AWARE's CEDAW Shadow Report 2011 to ask for changes.</p> <p>Main activities:</p> <ul style="list-style-type: none"> • Monitoring of WSH cases that were reported to AWARE, to track the experience that the complainants had with various authorities • Legal review of WSH laws in India, United Kingdom, Malaysia, South Korea, USA, Australia, Hong Kong and New Zealand • Raised the issue of WSH to Member of Parliament Indranee Rajah, who asked for more information • Drafted a new research paper focusing on the inadequacies of current laws and mechanisms
Future plans	<ul style="list-style-type: none"> • Advocate for the government's Cyber Bullying Act to be expanded into a Harassment Act, or for the Employment Act to include protection against sexual harassment • Seek the assistance of Members of Parliament to have the issue tabled and debated in Parliament
